

Stallion Enrollment/Participation Rules:



- 1.** Stallion must have full COLOR registration through one of the Associations listed to be eligible.
- 2.** All stud fees, including Private Treaty, must meet a minimum stud fee of \$350 in order to participate in the CASH FOR COLOR, LLC Program.
- 3.** Stallion nomination forms must be completed by stallion owner or stallion agent and submitted to the CASH FOR COLOR, LLC with a copy of Stallion's Color registration papers and enrollment fee.
- 4.** Enrollment Fee is \$500.00 annually
- 5.** Enrollment serves as authorization to sell (1) breeding to Stallion
- 6.** Breeding's will be sold at 1/2 of the listed stud fee plus \$100 Admin Fee.
- 7.** Sold breeding is non transferable. Breeding and Enrollment fees are Non-refundable.
- 8.** Make checks payable to CASH FOR COLOR, LLC. 375 Dukes Rd Mansfield, Georgia 30055, Credit Card Payment accepted with a 4% convenience fee and/or PayPal Friends and Family mjpp@cashforcolor.com *****Returned Check Fee - \$50
- 9.** If a stallion breeding does not sell by June 30, the stallion owner has the opportunity to purchase the breeding to secure its offspring's eligibility for that year. All stallion owner purchases must be completed by August 1st of the current year.
- 10.** Upon payment of Stallion enrollment fee and sale of the donated breeding thru CASH FOR COLOR, LLC, ALL COLOR foals by the Stallion are eligible to nominate and show in its respective classes in the CASH FOR COLOR Program.
- 11.** Stallion owners will receive (1) Free foal nomination annually (\$200.Benefit) *These Foal Nominations must be assigned by the end of the foaling year, cannot be rolled from one year to the next or transferred for another breeder's use.*
- 12.** Stallion Enrollment authorizes CASH FOR COLOR, LLC to use the stallion and its offspring in advertisements to promote the CASH FOR COLOR, LLC Program.
- 13.** The stallion owner will receive 10% of the total purse won by their progeny each year. W-9 Form required each year to receive payment.



- 14.** Annually, all enrolled stallion owners must submit a new signed enrollment contract by October 31st of the year prior to the upcoming breeding season to continue participation of stallion in the CASH FOR COLOR, LLC Program. Stallions will not be included in any applicable breeding year promotional materials until the contract is received. Enrollment forms can be found on the website
- 15.** Breeding sales and Stallion Open Enrollment will begin each year after the Color Breed Congress Show ends and that year's CASH FOR COLOR, LLC Awards have been distributed.
- 16.** Stallion Enrollment closes on June 30th of each year. THERE WILL BE NO EXCEPTIONS TO THIS DATE.
- 17.** Jr. Stallions donate (1) breeding per year until foals are Yearling age. Then the \$500 annual enrollment begins. BREEDING MUST SELL each year to maintain eligibility during the "Junior Stallion" enrollment period.
- 18.** All Stallion Owners are asked to support CASH FOR COLOR, LLC by sharing the program posts to your Social Media pages, encourage your friends to like and share CASH FOR COLOR, LLC information for greater exposure and help advertise all breeding's that are available.
- 19.** All stallion owners are encouraged to sell sponsorships to help support the program's administrative fees, acquire prizes, gain partnerships and funds for payouts.
- 20.** All Stallion Owners are asked to add a CASH FOR COLOR, LLC logo and web address, www.cashforcolor.com , to your social media pages and advertisements.
